

RESOLUTION No. 03-144

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; AMENDING RESOLUTION NO. 02-56 TO PROVIDE THAT IF ON ANY GIVEN YEAR, NO APPLICATIONS ARE FILED FROM A PARTICULAR GENDER GROUP, THE KEY TO THE TOWN SCHOLARSHIPS WILL BE AWARDED TO TWO (2) GRADUATING SENIORS RESIDING IN THE TOWN; ADVANCING THE DEADLINE FOR SUBMITTALS; ADVANCING THE DATE OF THE AWARD, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The Town Council adopted Resolution No. 02-56 which established the Key to the Town Scholarship Award (the "Scholarship") and set dates for submittal and issuance of the award; and

WHEREAS, Resolution No. 02-56 contemplated awarding the scholarship to one male and one female applicant at the annual June Town Council Meeting; and

WHEREAS, in 2003, there were no applications from male students; and

WHEREAS, the Education Advisory Board has recommended that the Town Council award the Scholarship to the top two female applicants for the award and further recommends that the Town Council advance the deadline date for future Scholarship application submittals to April 1, and the award date to the annual May Town Council meeting rather than the June Town Council Meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above Recitals are true and correct and incorporated herein by this reference.

Section 2. Amendment to Scholarship. Sections 2 and 3 of Resolution No. 02-56 are amended to read as follows:



Section 2. Scholarship. The Scholarship shall be awarded beginning in June of 2002 and for the next two (2) years thereafter to a male and a female graduating senior that reside in the Town, however if in any given year there is no application from a particular gender group, the scholarships will be awarded to two (2) graduating seniors residing in the Town. Scholarship recipients shall receive (i) a \$500.00 scholarship sponsored by the Keyes Company; (ii) an official "Key to the Town of Miami Lakes;" and (iii) a recognition certificate from the Town. Recipients shall receive their scholarships at a regularly scheduled Town Council Meeting during the month of ~~June~~ May.

Section 3. Application Packages. Applicants shall submit the following items to the Town Clerk by no later than ~~May 1st~~ April 1st of each year


Section 3. Effective Date. This Resolution shall become effective immediately upon its adoption and shall be implemented retrospectively in 2003.
