A RESOLUTION OF THE TOWN COUNCIL OF TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE FIRST AMENDMENT TO THE **AGREEMENT** BETWEEN KIMLEY-HORN AND ASSOCIATES, INC. AND THE TOWN LAKES FOR TOWN ENGINEER **MIAMI** THE **TOWN SERVICES**; AUTHORIZING **ATTORNEY MANAGER AND TOWN** TO IMPLEMENT THE TERMS AND CONDITIONS OF THE AGREEMENT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS: AUTHORIZING THE MAYOR TO EXECUTE THE CONTRACT; AND **PROVIDING FOR** AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the "Town") entered into an agreement with Kimley-Horn and Associates (the "Consultant") for day-to-day services as Town Engineer (the "Agreement"); and

WHEREAS, the Town Council desires to amend the Agreement so that Consultant may continue to perform services to the Town as Town Engineer for the duration of the fiscal year.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The foregoing Recitals are true and correct and are incorporated herein by this reference.

Section 2. Approval of Amendment. The First Amendment to the Project Agreement between Kimley-Horn and Associates, Inc. and the Town of Miami Lakes for day-to-day services as the Town Engineer (the "Amendment"), a copy of which is attached as

Exhibit ""A," together with such non-material changes as may be acceptable to the Town Manager and approved as to form and legality by the Town Attorney, is approved.

Section 3. Authorization of Town Officials. The Town Manager and Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Amendment.

<u>Section 4.</u> <u>Authorization of Fund Expenditure.</u> The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the Amendment.

Section 5. Execution of Contract. The Mayor is authorized to execute the Contract on behalf of the Town.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.

FIRST AMENDMENT TO PROJECTAGREEMENT BY AND BETWEEN KIMLEY-HORN AND ASSOCIATES, INC. AND THE TOWN OF MIAMI LAKES FOR TOWN ENGINEER SERVICES

This First Amendment to the Project Agreement between Kimley-Horn and Associates, Inc. and the Town of Miami Lakes for Town Engineer (the "First Amendment") is made and entered into this 10 th day of _______, 2003, by and between the Town of Miami Lakes, Florida, a municipal corporation of the State of Florida (the "Town") and Kimley-Horn and Associates, Inc., a Florida corporation (the "Consultant").

WHEREAS, on November 12th, 2002, the Town Council approved an Agreement whereby Consultant would provide day-to-day engineering services (the "Services") to the Town as requested (the "Agreement"); and

WHEREAS, the Town desires to amend the maximum compensation permitted under the Agreement so that Consultant can continue to provide services to the Town for the duration of the Fiscal Year.

NOW THEREFORE, in consideration of the mutual covenants set forth in this First Amendment, the parties agree as follows:

- 1. <u>Amendment to Section 4.1.</u> The parties amend Section 4.1 of the Agreement to read as follows:
 - 4.1 <u>Hourly Compensation.</u> TOWN agrees to pay CONSULTANT compensation at CONSULTANT'S hourly rates, up to a maximum amount not to exceed \$40,000.00 \$96,000.00. CONSULTANT's hourly rates shall be those specified in the Continuing Services Agreement. Prior to exceeding the budgeted amount, the CONSULTANT shall inform the TOWN and obtain authorization from the Town Council.

2. <u>No Further Modifications</u>. All other terms and conditions of the Agreement not in conflict or superseded by this First Amendment shall remain in full force and effect as if set forth in full herein.
