

RESOLUTION NO. 03-187

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, ACCEPTING THE PROPOSAL FROM APAC GROUP, INC. FOR THE TRANSFER OF FILL MATERIAL FROM ITS CURRENT LOCATION AT AMELIA EARHART PARK TO ROYAL OAKS PARK; AUTHORIZING APPROPRIATE TOWN OFFICIALS TO EFFECTUATE THE TRANSFER OF FILL TO ROYAL OAKS PARK; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE REQUIRED DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Miami Lakes (the “Town”) requested proposals from three (3) contractors to load and haul fill material from Amelia Earhart Park to Royal Oaks Park; and

**WHEREAS**, after reviewing all proposals, the Town Manager recommends the selection of APAC Group, Inc.; and

**WHEREAS**, the Town Council finds that accepting the proposal from APAC Group, Inc. is in the best interest of the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1.**     **Recitals.**     The foregoing Recitals are true and correct and are incorporated herein by this reference.

**Section 2.**     **Approval of APAC Group, Inc.**     APAC Group, Inc. is selected to load and haul approximately 3,600 cubic yards of fill from its current location at Amelia Earhart Park to Royal Oaks Park, as described in the proposal, attached as Exhibit “A,” contingent upon APAC’s submittal of certificates of insurance acceptable to the Town Manager and the execution

of any required indemnification or hold harmless agreement in a form acceptable to the Town Attorney.

**Section 3. Authorization of Fund Expenditure.** The Town Manager is authorized to expend budgeted funds to effectuate the transfer of fill to Royal Oaks Park.

**Section 4. Execution of Agreement.** The Town Manager is authorized to execute any documents required for this transfer of fill to Royal Oaks Park on behalf of the Town.

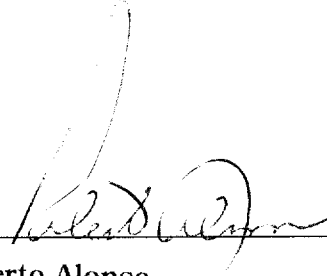
**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.

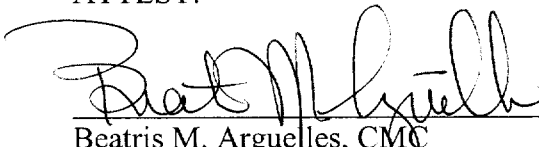

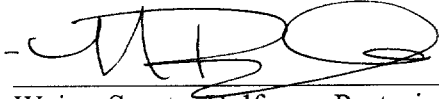

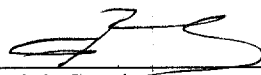
**The CONTRACTOR'S Fixed Price for this Project shall be \$3.45/Yard or \$62.10 per Truckload based on an 18 Yard truck.**
