

RESOLUTION NO. 04-241

A RESOLUTION OF THE TOWN COUNCIL OF TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE “STORSAFE AT MIAMI LAKES” PLAT, BEING A REPLAT OF A PORTION OF TRACT “B”, “MIAMI LAKES BUSINESS PARK SECTION ONE”, ACCORDING TO THE PLAT THEREOF AS RECORDED IN PLAT BOOK 126 AT PAGE 54 OF THE PUBLIC RECORDS OF MIAMI DADE COUNTY, FLORIDA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 28 of the Miami-Dade County Code, Storsafe Miami Lakes (the “Applicant”), has applied for approval of a Final Plat for “STORSAFE AT MIAMI LAKES,” a copy of the Final Plat is attached as Exhibit “A” and incorporated into this Resolution by reference; and

WHEREAS, the Town Council has been advised by Miami-Dade County staff (acting in their capacity as Town Staff) that the Applicant has met the conditions imposed by the Miami Dade County Plat Committee and has complied with all applicable provisions of Chapter 28 of the Miami Dade County Code and the Town Code.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated in to this Resolution by this reference.

Section 2. Approval. The Final Plat approval for “STORSAFE AT MIAMI LAKES”, more particularly described as:

TRACT “B”, MIAMI LAKES BUSINESS PARK SECTION ONE, ACCORDING TO THE PLAT THEREOF AS RECORDED IN PLAT BOOK 126 AT PAGE 54 OF THE PUBLIC RECORDS OF MIAMI-DADE COUNTY, FLORIDA, LYING AND MORE PARTICULARLY BEING DESCRIBED AS FOLLOWS:

BEGIN AT THE NORTHWEST CORNER OF SAID TRACT “B”; THENCE RUN SOUTH 89 DEGREES 52 MINUTES 27 SECONDS EAST, ALONG THE NORTH BOUNDARY OF SAID TRACT “B”, FOR 688.31 FEET TO A POINT ON THE NEXT DESCRIBED CIRCULAR CURVE, SAID POINT BEARS

SOUTH 55 DEGREES 08 MINUTES 13 SECONDS WEST FROM THE RADIUS POINT OF SAID CURVE; THENCE SOUTHEASTERLY, ALONG A CIRCULAR CURVE TO THE LEFT, HAVING A RADIUS OF 525.00 FEET AND A CENTRAL ANGLE OF 05 DEGREES 18 MINUTES 01 SECONDS, FOR AN ARC DISTANCE OF 48.57 FEET TO A POINT OF TANGENCY; THENCE SOUTH 40 DEGREES 09 MINUTES 48 SECONDS EAST FOR 117.40 FEET (SAID LAST TWO COURSES BEING COINCIDENT WITH THE EASTERLY BOUNDARY OF SAID TRACT "B"); THENCE NORTH 89 DEGREES 52 MINUTES 27 SECONDS WEST, ALONG A LINE 128.00 FEET, SOUTH OF AND PARALLEL WITH THE NORTH BOUNDARY OF SAID TRACT "B", FOR 215.00 FEET; THENCE SOUTH 00 DEGREES 07 MINUTES 33 SECONDS WEST FOR 22.00 FEET; THENCE NORTH 89 DEGREES 52 MINUTES 27 SECONDS WEST, ALONG A LINE 150.00 FEET SOUTH OF AND PARALLEL WITH THE NORTH BOUNDARY OF SAID TRACT "B", FOR 578.54 FEET; THENCE NORTH, ALONG THE WEST LINE OF SAID TRACT "B", FOR 150.00 FEET TO THE POINT OF BEGINNING. LYING AND BEING IN THE TOWN OF MIAMI LAKES, MIAMI-DADE COUNTY, FLORIDA.

Is granted.

Section 3. Authorization. The Town Manager and the Town Clerk are authorized to sign the face of the Final Plat.

Section 4. Recordation. The Town Clerk shall forward this Resolution and the Original Final Plat to Miami-Dade County for recording in the Public Records of Miami Dade County, Florida. The applicant shall pay the costs of recording the Final Plat, as well as the Town's actual cost for a surveyor to approve the Final Plat as required by Chapter 177, Florida Statutes.


Section 5. Effective Date. This Resolution shall take effect immediately upon adoption by the Town Council.



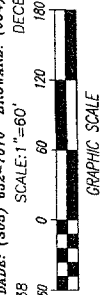

LEGAL DESCRIPTION:

KNOW ALL MEN BY THESE PRESENTS: That J.I. KISLAK, INC., a New Jersey Corporation, has caused to be made the attached plat of "STORSAFE AT MIAMI LAKES", the same being a replat of a portion of Tract B, Miami Lakes Business Park Section One, according to the plat thereof as recorded in Plat Book 126 at Page 54, of the Public Records of Miami-Dade County, Florida, and being more particularly described as follows:

Begin at the Northwest corner of said Tract "B"; thence run South 89 degrees 52 minutes 27 seconds East, along the North boundary of said Tract "B", for 688.31 feet to a point on the next described circular curve, said point bears South 55 degrees 08 minutes 13 seconds West from the radius point of said curve; thence Southwesterly, along a circular curve to the left, having a radius of 525.00 feet and a central angle of 05 degrees 01 minutes 18 seconds, for an arc distance of 48.57 feet to a point of tangency; thence South 40 degrees 09 minutes 48 seconds East for 117.40 feet (said last two courses being coincident with the Easterly boundary of said Tract "B"); thence North 89 degrees 52 minutes 27 seconds West, along a line 128.00 feet, south of and parallel with the North boundary of said Tract "B", for 215.00 feet; thence South 00 degrees 07 minutes 33 seconds West for 22.00 feet; thence North 89 degrees 52 minutes 27 seconds West, along a line 150.00 feet south of and parallel with the North boundary of said Tract "B", for 578.54 feet; thence North, along the west line of said Tract "B", for 150.00 feet to the Point of Beginning, Lying and being in the Town of Miami Lakes, Miami-Dade County, Florida.

TOWN OF MIAMI LAKES PLAT RESTRICTIONS:

That N.W. 79th Court and Palmetto Frontage Road as shown on the attached plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors or assigns, the reversion or reversions thereof, whenever discontinued by law.

MIAMI-DADE COUNTY PLAT RESTRICTIONS:

That the use of septic tanks will not be permitted within this subdivision, unless approved for temporary use, in accordance with County or State regulations. That individual wells shall not be permitted within this subdivision, except for sprinkler systems, swimming pools, and/or air-conditioners. That all new electric and communication lines may be installed overhead, service conductors from the pole to the building/structure shall be an underground service lateral.

OWNER'S PLAT RESTRICTIONS:

That the utility easements, as shown on the attached plat, are hereby reserved for the installation and maintenance of Public Utilities. IN WITNESS WHEREOF: That J.I. 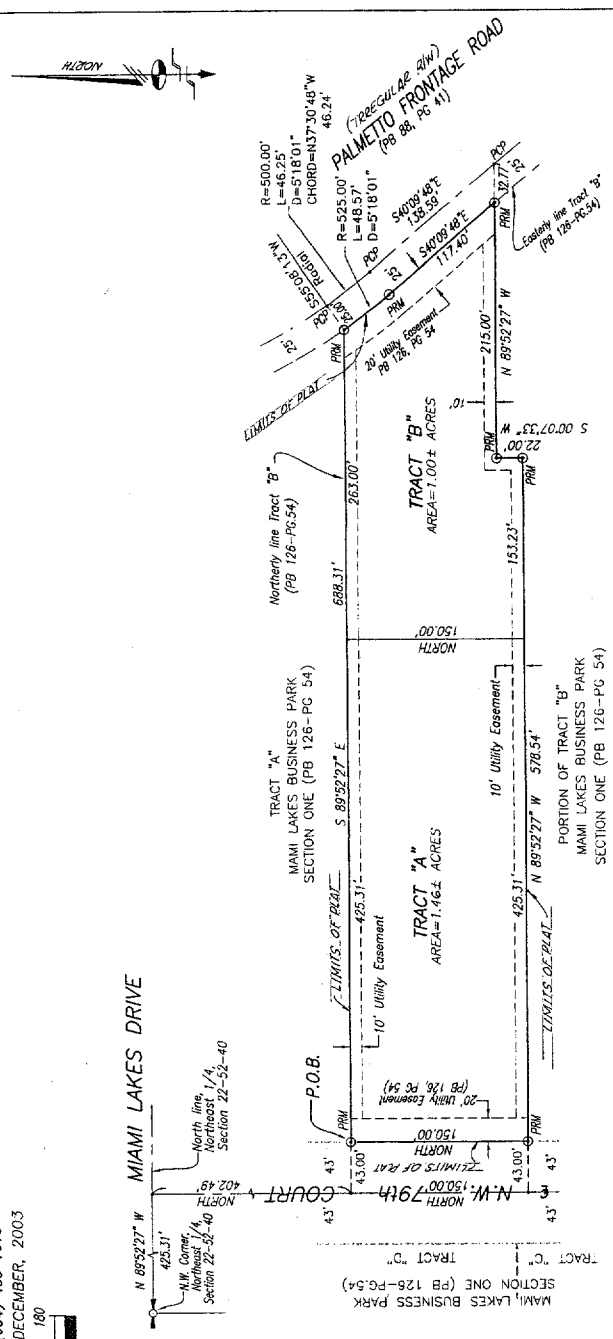

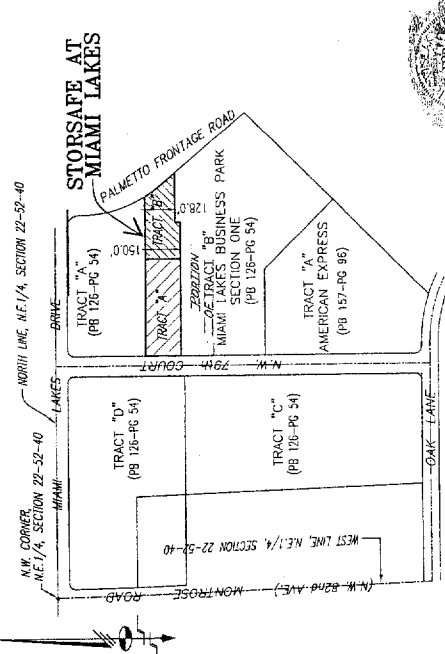
