A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA APPROVING THE PROJECT AGREEMENT BETWEEN KIMLEY-HORN AND ASSOCIATES, INC. AND THE TOWN OF MIAMI LAKES FOR NW 162nd STREET AND 82nd TRAFFIC SIGNAL DESIGN; AUTHORIZING THE TOWN MANAGER AND TOWN ATTORNEY TO IMPLEMENT THE TERMS AND CONDITIONS OF THE AGREEMENT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE AGREEMENT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the "Town") has retained the services of Kimley-Horn and Associates, Inc. ("Kimley-Horn") as Town Engineer; and

WHEREAS, the Town has been working with Miami-Dade County (the "County") to improve the traffic congestion at the intersection of NW 162nd Street and 82nd Avenue (the "Intersection"); and

WHEREAS, both the Town and County have determined that a traffic signal at the intersection would improve the traffic congestion; and

WHEREAS, the County has agreed to construct the traffic signal improvements (the "Project") but does not presently have a design professional available to expedite the process; and

WHEREAS, Kimley-Horn has agreed to provide the design services for the Project; and WHEREAS, the Town Council finds that approval of the project agreement between the Town and Kimley-Horn for design of traffic signal improvements at NW 162nd Street and 82nd Avenue is in the best interests of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

The above recitals are true and correct and incorporated Section 1. Recitals. into this resolution by this reference.

Section 2. Approval of Agreement. The Project Agreement between Kimley-Horn and Associates, Inc. and the Town of Miami Lakes for design of traffic signal improvements at NW 162nd Street and 82nd Avenue (the "Agreement"), a copy of which is attached as Exhibit "A," together with such non-material changes as may be acceptable to the Town Manager and approved as to form and legality by the Town Attorney, is approved.

Authorization of Town Officials. The Town Manager and Town Section 3. Attorney are authorized to take all steps necessary to implement the terms and conditions of the Agreement.

Authorization of Fund Expenditure. Section 4. The Town Manager authorized to expend budgeted funds to implement the terms and conditions of the Agreement.

The Town Manager is authorized to execute Section 5. **Execution of Agreement.** the Agreement on behalf of the Town.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.
