

RESOLUTION No. 05-272

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA APPROVING \$20,000 IN FUNDING TO THE SCHOOL BOARD OF MIAMI-DADE COUNTY FOR ADULT EDUCATION CLASSES AT THE MIAMI LAKES COMMUNITY CENTER; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO ASSIST IN IMPLEMENTING THE CLASSES AT THE CENTER; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Miami Lakes (the "Town") entered into an affiliating agreement with the School Board of Miami-Dade County (the "School Board") on July 1, 2004, so that the School Board could provide adult education classes at the Town Community Center at 15151 Montrose Road (the "Center"); and

**WHEREAS**, the Tai Chi and Arts and Crafts classes offered at the Center are funded by a state grant; and

**WHEREAS**, the Town allocated \$10,400 to the School Board in Fiscal Year 2003-2004 so that additional classes including Ballet, Painting and Spanish, that were not already funded by the state grant, could be offered to Town residents; and

**WHEREAS**, additional funding is required to provide for the further expansion of classes at the Center including additional Ballet, Jazz and Spanish classes, as well as Karate; and

**WHEREAS**, the Town Council determines that an allocation of an additional funding of \$20,000.00 is in the best interests of the Town, in order to provide additional adult education classes to Town residents.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated into this resolution by this reference.

**Section 2. Approval of Allocation.** The allocation of \$20,000.00 in funding to the School Board, in order to provide for additional adult education classes at the Town Community Center, is approved.

**Section 3. Authorization of Town Manager.** The Town Manager is authorized to take all steps necessary to assist in implementing the classes at the Center.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
