Recommendation

It is recommended that the Town Council appoints Ms. Debra Eastman as the Town Clerk.

Background

The Town Clerk position became vacant on September 13, 2004. In the interim, Ms. Meighan J. Pier, CMC has been serving as a Town Clerk with the assistance of Ms. Evelyn Roig as a Deputy Clerk. The Town Clerk position was advertised at the end of last year. The Town Clerk position is an integral part of the Town of Miami Lakes management team; therefore, the position requires excellent organizational and interpersonal skills, as well as, a minimum of five years of government experience preferable as a municipal clerk.

We received approximately 34 resumes out of which we chose four candidates for interviews. They were: Beatris M. Arguelles, CMC, Debra E. Eastman, CMC, Cassandra P. Mitchell, CMC, and Evelyn Roig.

Interviews were conducted on January 13, 2005. The interview panel was composed of myself, Ms. Mariaelena Salazar, Ms. Meighan J. Pier, CMC (Village Clerk, Village of Palmetto Bay and Interim Town Clerk), and Ms. Sheila Paul, CMC (City Clerk, City of Doral). Based on the interviews, two top candidates were selected, Ms. Debra E. Eastman, CMC from Gilford, New Hampshire and Cassandra P. Mitchell, CMC from San Fernandina Beach, Florida. During the week of January 31, 2005, these candidates were scheduled for further discussion with Town personnel as well as meeting with Town Council members individually. Based on the final interviews, I am recommending Ms. Debra Eastman, CMC for the position of Miami Lakes Town Clerk with a salary of \$60,000 per year plus \$3,000 for moving expenses.

Ms. Debra E. Eastman, CMC has been a Town Clerk- Tax Collector for the Town of Gilford since 1982. She has completed the second level of the Master Municipal Clerk program and is a Certified Municipal Clerk. Her resume is attached for your reference.
