WHEREAS, on February 2, 2001, Miami-Dade County (the "County") and Prime Electrical Contractors, Inc. (the "Contractor") entered into an agreement whereby Contractor has provided street lighting maintenance services (the "Services") within the Town of Miami Lakes (the "Town"); and

WHEREAS, in November 2002, the Town took on responsibility of the Services from the County; and

WHEREAS, on March 14, 2003, the Town formalized a service contract with the Contractor (the "Contract") (Exhibit "A") to continue with the services that were previously bid by the County; and

WHEREAS, the Town recently bid out street lighting maintenance services; and

WHEREAS, the Town Council desires to amend this Contract to provide retroactive compensation for work performed by Contractor to this date.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of First Amendment. The First Amendment to the Contract between Prime Electrical Contractors, Inc. and the Town of Miami Lakes (the "First Amendment"), a copy of which is attached as Exhibit "B," together with such non-material changes as may be acceptable to the Town Manager and approved as to form and legality by the Town Attorney, is approved.

Section 3. Authorization of Town Officials. The Town Manager and Town Attorney are authorized to take all actions necessary to implement the terms and conditions of the First Amendment.

Section 4. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the First Amendment.

<u>Section 5.</u> <u>Execution of Agreement.</u> The Mayor is authorized to execute the First Amendment on behalf of the Town.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.
