## RESOLUTION NO. 05-299

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE AMENDMENT TO THE CONTRACT FOR INFORMATION TECHNOLOGY SUPPORT SERVICES BETWEEN SEVERN **TRENT ENVIRONMENTAL** SERVICES, INC. AND THE TOWN OF MIAMI LAKES: AUTHORIZING TOWN OFFICIALS TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS OF AMENDMENT: AUTHORIZING THE **TOWN** MANAGER TO **EXPEND** BUDGETED **FUNDS**; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE AMENDMENT TO THE AGREEMENT: AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on September 1, 2004, the Town of Miami Lakes (the "Town") entered into a Contract (the "Contract") whereby Contractor would provide information technology support services to the Town (the "Services"); and

WHEREAS, Town staff is presently preparing bid documents for information technology services; and

WHEREAS, the Town will need to continue to obtain the Services until a subsequent contract is awarded; and

WHEREAS, the Town desires to amend the Contract so that Contractor may continue to provide services to the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

- Section 1. Recitals. The above Recitals are true and correct and incorporated herein by this reference.
- Section 2. Approval of First Amendment. The First Amendment to the Contract between Severn Trent Environmental Services, Inc. and the Town of Miami Lakes (the "First)

Amendment"), a copy of which is attached as Exhibit "1," together with such non-material changes as may be acceptable to the Town Manager and approved as to form and legality by the Town Attorney, is approved.

Section 3. Authorization of Town Officials. The Town Manager and Town Attorney are authorized to take all actions necessary to implement the terms and conditions of the First Amendment.

Section 4. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the First Amendment.

Section 5. Execution of Agreement. The Town Manager is authorized to execute the First Amendment on behalf of the Town.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.
