

**RESOLUTION NO. 05-301**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; ACCEPTING THE REQUEST OF JOSE A. SOTO AND ANA M. SOTO TO REDUCE A PREVIOUSLY ASSESSED CODE ENFORCEMENT FINE FOR CASE NO. C2003-2199; DIRECTING THE TOWN MANAGER TO EXECUTE ANY REQUIRED DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Miami Lakes (the “Town”), through its Code Enforcement Department, issued Citation No. C2003-2199 to Jose A. Soto and Ana M. Soto (the “Violators”); and

**WHEREAS**, the violation was subsequently corrected and the Violators paid the Town the fine of \$11,210.75; and

**WHEREAS**, the Violators have requested that the Town reduce the fine and the Town Manager having reviewed the file has recommended to the Town Council approval of a reduction of the fine to \$5,605.37.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and are incorporated herein by this reference.

**Section 2. Reduction of Fine.** The civil penalty/fine for Code Enforcement Case No. C2003-2199 is reduced to \$5,605.37. The Town Manager is authorized to execute appropriate documents to facilitate the return of the balance of already paid fines to the Violators.

**Section 3. Effective Date.** This Resolution shall be effective immediately upon adoption.
