

RESOLUTION NO. 05- 311

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; ACCEPTING THE REQUEST OF MARIO COLLAZO AND ANAIS COLLAZO TO REDUCE A PREVIOUSLY ASSESSED CODE ENFORCEMENT FINE FOR CASE NO. C2003-2200; DIRECTING THE TOWN MANAGER TO EXECUTE ANY REQUIRED DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the “Town”), through its Code Enforcement Department, issued Citation No. C2003-2200 to Mario Collazo and Anais Collazo (the “Violators”); and

WHEREAS, the violation was subsequently corrected and the Violators paid the Town the fine of \$11,333.25; and

WHEREAS, the Violators have requested that the Town reduce the fine and the Town Manager having reviewed the file has recommended to the Town Council approval of a reduction of the fine to \$5,666.63.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Reduction of Fine. The civil penalty/fine for Code Enforcement Case No. C2003-2200 is reduced to \$5,666.63. The Town Manager is authorized to execute appropriate documents to facilitate the return of the balance of already paid fines to the Violators.

Section 3. Effective Date. This Resolution shall be effective immediately upon adoption.
