

RESOLUTION NO. 06- 392

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AWARDED JUSTIN KAEEN CHANG AND NICOLE MCGRATH WITH THIS YEAR'S "KEY TO THE TOWN OF MIAMI LAKES SCHOLARSHIP"; AUTHORIZING THE TOWN MANAGER TO TAKE ALL ACTIONS NECESSARY TO IMPLEMENT THE SCHOLARSHIP; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on February 12, 2002, the Town Council adopted Resolution No. 02-56 creating the Key to the Town of Miami Lakes Scholarship (the "Scholarship") to recognize two outstanding high school seniors each year that reside in the Town of Miami Lakes (the "Town"); and

WHEREAS, the Scholarship Application process provides that the Town's Education Advisory Board shall review the application packages and recommend two (2) students to the Town Council each year; and

WHEREAS, the Town's Education Advisory Board unanimously recommends to the Town Council Justin Kaen Chang and Nicole McGrath as this year's recipients of the Scholarship; and

WHEREAS, the Town Council accepts this recommendation of the Education Advisory Board and awards the Scholarship to Justin Kaen Chang and Nicole McGrath.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by reference.

Section 2. Scholarship. The Town Council hereby awards the Scholarship to Justin Kaen Chang and Nicole McGrath, to each in the amount of one-thousand dollars (\$1,000.00) which shall be funded by the Graham Companies. The Scholarship recipients shall receive an official "Key to the Town of Miami Lakes" and a recognition certificate from the Town.

Section 3. Authorization of Town Officials. The Town Manager and/or his designee are authorized to take all actions necessary to implement the Scholarship.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.


