

RESOLUTION NO. 06- 410

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; ACCEPTING THE REQUEST OF OSCAR MEJIA, NEW OWNER OF THE PROPERTY TO REDUCE A PREVIOUSLY ASSESSED CODE ENFORCEMENT FINE FOR CASE NO. C2005-0525; DIRECTING THE TOWN MANAGER TO EXECUTE ANY REQUIRED DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the "Town"), through its Code Enforcement Department, issued Citation No. C2005-0525 to Noel Burey, the original owner of the property (the "Violator"); and

WHEREAS, the violation was subsequently corrected by the new owner Oscar Mejia; and

WHEREAS, the new owner paid the Town the original fine amount due of \$10,884.37; and

WHEREAS, the new owner has requested that the Town reduce the fine and the Town Manager having reviewed the file has recommended to the Town Council approval of a reduction of the fine to \$5,442.19.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Reduction of Fine. The civil penalty/fine for Code Enforcement Case No. C2005-0525 is reduced to \$5,442.19. The Town Manager is authorized to execute the appropriate documents to facilitate the return to the Violator of the balance of the fines already paid.

Section 3. **Effective Date.** This Resolution shall be effective immediately upon adoption.
