A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE LEASE AND MAINTENANCE AGREEMENT FOR THE UPGRADE AND RELOCATION OF COPIERS FOR THE POLICE DEPARTMENT AND THIRD FLOOR OF TOWN HALL; AUTHORIZING TOWN OFFICIALS TO TAKE ALL STEPS NECESSARY TO IMPLEMENT THE TERMS OF THE AGREEMENTS; AUTHORIZING THE TOWN MANAGER TO **EXPEND** BUDGETED **FUNDS:** AUTHORIZING THE MANAGER TO EXECUTE THE AGREEMENTS: AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town conducted an analysis of its photo copier machines and determined that upgrades were required to enhance efficiency; and

WHEREAS, the Town desires to piggyback off the existing State of Florida contract (No. GS-25F-0023M) for the lease of an upgraded copier machine; and

WHEREAS, the Town finds that the State's lease and maintenance agreements for the upgrades and relocation of the copiers are in the best interest of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

- <u>Section 1.</u> <u>Recitals.</u> The foregoing Recitals are true and correct and are incorporated herein by this reference.
- Section 2. Approval of Agreements. The Town hereby approves the existing State of Florida agreement for the upgrade and maintenance of the copiers within the Town.
- Section 3. Authorization of Town Officials. The Town Manager and Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Agreements.

Section 4. Authorization of Fund Expenditure. Notwithstanding the limitations imposed upon the Town Manager pursuant to the Town's Purchasing Procedures Ordinance, the Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the Agreements.

Section 5. Execution of Agreement. The Town Manager is authorized to execute the Agreements on behalf of the Town, to execute any required agreements and/or documents to implement the terms and conditions of the Agreements and to execute any extensions and/or amendments to the Agreements, subject to the approval as to form and legality by the Town Attorney.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.
