## RESOLUTION NO. 06-424

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE AGREEMENTS BETWEEN THE TOWN OF MIAMI MCCi FOR **PURCHASE** LAKES AND THE LASERFICHE AND **MUNIAGENDA SOFTWARE**; AUTHORIZING TOWN OFFICIALS TO TAKE ALL STEPS NECESSARY TO IMPLEMENT THE TERMS OF THE AGREEMENTS: AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE MANAGER TO EXECUTE THE AGREEMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town desires to customize and automate its agenda process and maximize its document management systems; and

WHEREAS, MCCi, a division of Municipal Code Corporation, provides innovative technology solutions for local government; and

WHEREAS, MCCi has provided proposals to the Town for the purchase of customized MuniAgenda software and Laserfiche software; and

WHEREAS, the Town finds that the agreements with MCCi for the purchase and technology support of MuniAgenda and Laserfiche software are in the best interest of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The foregoing Recitals are true and correct and are incorporated herein by this reference.

Section 2. Approval of Agreements. The agreements for the purchase of MuniAgenda and Laserfiche software between the Town of Miami Lakes and MCCi (the

"Agreements"), copies of which are attached as Exhibits "A" and "B" respectively, together with such changes as may be acceptable to the Town Manager and approved as to form and legality by the Town Attorney, are approved.

Section 3. Authorization of Town Officials. The Town Manager and Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Agreements.

Section 4. Authorization of Fund Expenditure. Notwithstanding the limitations imposed upon the Town Manager pursuant to the Town's Purchasing Procedures Ordinance, the Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the Agreements.

Section 5. Execution of Agreement. The Town Manager is authorized to execute the Agreements on behalf of the Town, to execute any required agreements and/or documents to implement the terms and conditions of the Agreements and to execute any extensions and/or amendments to the Agreements, subject to the approval as to form and legality by the Town Attorney.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.
