RESOLUTION NO. 06- 428

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; ACCEPTING THE REQUEST OF ROYAL OAKS PLAZA, INC. TO REDUCE A PREVIOUSLY ASSESSED CODE COMPLIANCE FINE FOR CASE NO. C2005-1053; DIRECTING THE TOWN MANAGER TO EXECUTE ANY REQUIRED DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the "Town"), through its Code Compliance Department, issued Citation No. C2005-1053 to Royal Oaks Plaza, Inc. (the "Violator"); and

WHEREAS, the Violator subsequently corrected the violation and paid the Town the accrued fines of \$4,315.36; and

WHEREAS, the Violator filed an appeal in the Eleventh Judicial Circuit Court in and for Miami-Dade County, Florida, Case # AP-154 AP ("Appeal"), which is currently pending and no dismissal has been filed; and

WHEREAS, the Violator requested that the Town reduce the fine; and

WHEREAS, the Town Manager, having reviewed the file, recommends to the Town Council approval of a reduction of the fine to \$3,020.76; and

WHEREAS, any reduction and refund of the balance of the fine is contingent on the filing of a dismissal with prejudice of the Appeal by the Violator.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1</u>. <u>Recitals.</u> The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Reduction of Fine. The fine for Code Compliance Case No. C2005-1053 is reduced to \$3,020.76 contingent upon dismissal with prejudice of the

Appeal. The Town Manager is authorized to execute appropriate documents to facilitate the return of the balance of the fine the Violator already paid, once the Violator files a notice of voluntary dismissal with prejudice of the appeal and the Town is able to confirm that the Appeal is dismissed.

Section 3. Effective Date. This Resolution shall be effective immediately upon adoption.
