

RESOLUTION NO. 06- ~~454~~

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; ACCEPTING THE REQUEST OF ALBERTO DARSA AND ADALIS DARSA TO REDUCE A PREVIOUSLY ASSESSED CODE COMPLIANCE FINE FOR CASE NO. C2004-0852; DIRECTING THE TOWN MANAGER TO EXECUTE ANY REQUIRED DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the “Town”), through its Code Compliance Department, issued Citation No. C2004-0852 to Alberto Darsa and Adalis Darsa (the “Violators”); and

WHEREAS, the Violators were issued a Citation, the violation was subsequently corrected and the Violators paid the Town the fine of \$6,822.61; and

WHEREAS, the Violators have requested that the Town reduce the fine and the Town Manager having reviewed the file has recommended to the Town Council approval of a reduction of the fine to \$3,411.30.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Reduction of Fine. The civil penalty/fine for Code Compliance Case No. C2004-0852 is reduced to \$3,411.30. The Town Manager is authorized to execute appropriate documents to facilitate the return of the balance of already paid fines to the Violators.

Section 3. Effective Date. This Resolution shall be effective immediately upon adoption.
