

RESOLUTION NO. 06-464

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; ACCEPTING THE REQUEST OF MAURICE F. LEMOINE AND ISAURA LEMOINE TO REDUCE A PREVIOUSLY ASSESSED CODE COMPLIANCE FINE FOR CASE NO. C2005-1046; DIRECTING THE TOWN MANAGER TO EXECUTE ANY REQUIRED DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the "Town"), through its Code Enforcement Compliance, issued Citation No. C2006-1046 to Maurice F. Lemoine and Isaura Lemoine (the "Violators"); and

WHEREAS, the Violators were issued a Citation, the violation was subsequently corrected and the Violators paid the Town the fine of \$3,172.00; and

WHEREAS, the Violators have requested that the Town reduce the fine; and

WHEREAS, the Town Manager reviewed the file and has been unable to reach an agreement with the Violators as to the amount of the reduction, and therefore recommends no reduction.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Reduction of Fine. The civil penalty/fine for Code Compliance Case No. C2006-1046 is reduced to \$2,172.00. The Town Manager is authorized to execute appropriate documents to facilitate the return of the balance of already paid fines to the Violators.

Section 3. Effective Date. This Resolution shall be effective immediately upon adoption.
