

RESOLUTION No. 07- 526

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AMENDING RESOLUTION NUMBER 05-313 REGARDING THE USE OF THE MIAMI LAKES YOUTH CENTER FUND; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Miami Lakes (the "Town") approved Resolution Number 05-313 authorizing the Town Manager and Town Attorney to create a Miami Lakes Youth Center Fund in order to raise money for the creation of a youth center in the Town; and

**WHEREAS**, the Town Council desires to amend the purpose of the Miami Lakes Youth Center Fund to fund and use these funds for the operational costs of youth recreational activities and programs.

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein by this reference.

**Section 2. Amending Resolution Number 05-313.** Resolution Number 05-313 is hereby amended to read as follows<sup>1</sup>:

...

**Section 2. Creation of Youth Center Fund.** The Town Council hereby authorizes the Town Manager and Town Attorney to create a "Miami Lakes Youth Center Fund" in order to raise money for the creation of a youth center in the Town of Miami Lakes and to fund the operational costs of youth recreational activities and programs.

**Section 3. Expenditure of Funds.** The Town Manager is authorized to expend budgeted funds to prepare the required documents and begin the

fundraising process. The youth center funds may be used for the creation of a youth center and to fund the operational costs of youth recreational activities and programs.

**Section 3. Effective Date.** This resolution shall become effective immediately upon its adoption.


