

RESOLUTION NO. 07- 550

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AMENDING RESOLUTION NO. 01-15 TO INCREASE THE NUMBER OF MEMBERS OF THE YOUTH ACTIVITY TASK FORCE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution No. 01-15, adopted on April 21, 2001, the Town Council created the Youth Activities Task Force (the "Task Force") to explore the development of positive youth activities; and

WHEREAS, the Town Council desires to increase the number of members in the Task Force from nine (9) to sixteen (16).

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and are incorporated herein by this reference.

Section 2. Amending Resolution. Resolution No. 01-15 is hereby amended as follows¹:

Section 2. The Youth Activities Task Force shall consist of ~~nine~~ sixteen members. The members shall be appointed by the Mayor, subject to the approval of the Town Council. Two members shall represent and belong to the Miami Lakes Civic Association; ~~two members shall be residents of the Town~~ ~~appointed at large~~; one member shall represent the Miami-Dade

Police Department and be assigned to the Town of Miami Lakes; two members shall be high school students that reside in the Town; and the remaining ~~two nine~~ eleven members shall be selected from residents nominated by the members of the Town Council. ~~Each Councilmember shall be entitled to nominate one~~ resident.

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.


