WHEREAS, David Rodriguez bravely fought cancer at a young age and continued to assist those in need, even in the face of his dire illness; and

WHEREAS, David Rodriguez, after he passed away, has continued to serve as an inspiration to hundreds of youngsters, including youngsters from Miami Lakes who attended Dade Christian School; and

WHEREAS, the Town Council desires to recognize David Rodriguez’ service.

THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**
