

RESOLUTION NO. 09-737

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, REQUESTING THAT MIAMI-DADE COUNTY INSTALL APPROPRIATE TRAFFIC CONTROL AND SAFETY DEVICES AT THE INTERSECTION OF NW 67TH AVENUE AND MAIN STREET WITHIN THE TOWN OF MIAMI LAKES; DIRECTING THE TOWN CLERK TO FORWARD THE RESOLUTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the intersection of NW 67th Avenue (Ludlam Road) and Main Street within the Town of Miami Lakes (the "Town") presently contains a crosswalk for pedestrians crossing NW 67th Avenue; and

WHEREAS, the crosswalk has become increasingly dangerous as pedestrian traffic has increased; and

WHEREAS, recent tragic events have shown the necessity for appropriate traffic control and safety devices to be installed to increase safety at the intersection; and

WHEREAS, the Town Council believes that the installation of appropriate traffic control and safety devices will help to protect the health and safety of Town residents and guests using the crosswalk at the intersection.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Request for Appropriate Traffic Control and Safety Devices.
The Town Council respectfully requests that Miami-Dade County install appropriate traffic control and safety devices at the intersection of NW 67th Avenue and Main Street

to help to insure the health and safety of Town residents and guests using the crosswalk at the intersection.

Section 3. Direction to the Town Clerk. The Town Clerk is directed to forward a copy of this Resolution to Miami-Dade County Commissioner Natacha Seijas and the other members of the Miami-Dade County Commission.



Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
