

RESOLUTION NO. 09-155

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA DESIGNATING THE DAY OF AUGUST 1, 2009 AS "COMBAT CHILD OBESITY DAY"; AUTHORIZING THE TOWN MANAGER TO TAKE ALL STEPS NECESSARY TO SATISFY THE REQUIREMENTS OF THE DESIGNATION AND RAISE FUNDS IN SUPPORT OF THE DAY; AUTHORIZING THE TOWN MANAGER TO EXPEND FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Miami Lakes, Florida (the "Town") has named August, Fitness Month; and

WHEREAS, critical elements of fitness are eating healthy and weight control; and

WHEREAS, studies have shown that child obesity is one of the leading killers of children in the United States; and

WHEREAS, efforts to create awareness of child obesity can assist in alleviating child obesity; and

WHEREAS, the Town desires to focus on child obesity and seek to create awareness and promote solutions to child obesity during Fitness Month; and

WHEREAS, a Town fitness walk and exercise program is planned as part of Fitness Month; and

WHEREAS, the Town Council believes that approving the foregoing designation is in the best interest of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, THAT:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Designation of "Combat Child Obesity Day". The Day of August 1, 2009 shall be designated as "Combat Child Obesity Day".

Section 3. Authorization of the Town Manager. The Town Manager is authorized to take all actions necessary to satisfy the requirements of the designation of "Combat Child Obesity Day" and to seek private donations to support this initiative.

Section 4. Authorization of Fund Expenditures. Absent sufficient private donations the Town Manager is authorized to expend \$2,500 to promote Fitness Month in general and "Combat Child Obesity Day" specifically.


Section 5. Effective Date. This Resolution shall become effective immediately upon its adoption.


