RESOLUTION NO. 09-782

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; DENYING THE REQUEST OF GREGORY B. TAYLOR ON BEHALF OF JP MORGAN CHASE BANK TO REDUCE A PREVIOUSLY ASSESSED CODE COMPLIANCE FINE FOR CASE NO. C2008-0731; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the "Town"), through its Code Compliance Department, issued Citation No. C2008-0731 to Hiyam Kafie (the "Previous Owner") with notification to JP Morgan Chase Bank (the "Owner"); and

WHEREAS, ownership of the property was transferred to JP Morgan Chase Bank; and

WHEREAS, a Citation was issued and the violation was subsequently corrected; and

WHEREAS, the Owner has incurred a fine of \$5,708.90 which includes a Special Assessment Lien filed for corrections made to the property by the Town; and

WHEREAS, the Owner has requested that the Town reduce the fine and the Town Manager having reviewed the file has recommended to the Town Council approval of a 25% reduction of the fine of \$1,427.22 leaving a balance to be paid in the amount of \$4,281.68.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Payment of Fine. The Owner's request for reduction of the civil penalty/fine is hereby denied. The civil penalty/fine for Code Compliance Case No. C2008-0731 is \$5,708.90.

Section 3. Effective Date. This Resolution shall be effective immediately upon adoption.
