## **RESOLUTION NO. 09-784**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; DENYING THE REQUEST OF GREGORY B. TAYLOR ON BEHALF OF JP MORGAN CHASE BANK TO REDUCE A PREVIOUSLY ASSESSED CODE COMPLIANCE FINE FOR CASE NO. C2008-0245; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the "Town"), through its Code Compliance Department, issued Citation No. C2008-0245 to Hiyam Kafie (the "Previous Owner") with notification to JP Morgan Chase Bank (the "Owner"); and

WHEREAS, ownership of the property was transferred to JP Morgan Chase Bank; and

WHEREAS, a Citation was issued and the violation was subsequently corrected; and

WHEREAS, the Owner has incurred a fine of \$11,686.91 which includes a Special Assessment Lien filed for corrections made to the property by the Town; and

WHEREAS, the Owner has requested that the Town reduce the fine and the Town Manager having reviewed the file has recommended to the Town Council approval of a 25% reduction of the fine of \$2,921.73 leaving a balance to be paid in the amount of \$8,765.19.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1</u>. <u>Recitals.</u> The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Payment of Fine. The Owner's request for reduction of the civil penalty/fine is hereby denied. The civil penalty/fine for Code Compliance Case No. C2008-0245 is \$11,686.91.

Section 3. Effective Date. This Resolution shall be effective immediately upon adoption.
