## **RESOLUTION NO. 10-791**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, CO-DESIGNATING A PORTION OF NORTHWEST 89TH AVENUE DIRECTLY IN FRONT OF BARBARA GOLEMAN SENIOR HIGH SCHOOL AS NORTHWEST 89th AVENUE/"BARBARA GOLEMAN WAY;" AUTHORIZING TOWN OFFICIALS TO TAKE ALL STEPS NECESSARY TO IMMEDIATELY DESIGNATE THE ROAD; DIRECTING THE CLERK TO NOTIFY THE UNITED STATES POST OFFICE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Barbara Goleman dedicated her life to educating the children in this community; and

WHEREAS, Barbara Goleman is the only school teacher in Miami-Dade County's history to be named National Teacher of the Year; and

WHEREAS, Barbara Goleman Senior High School has been named by national publications as one of the best high schools in the United States.; and

WHEREAS, Barbara Goleman has always been a symbol of the best the teaching profession has to offer; and

WHEREAS, Barbara Goleman's legacy has set the standards for thousands of teachers who have followed in her footsteps; and

WHEREAS, teachers are the true heroes of the education process; and

WHEREAS, Barbara Goleman Senior High School has been an integral part of the community, partnering in town efforts to improve education; and

WHEREAS, pursuant to Section 2-1, Rule 9.02 of the Town Code (Miami-Dade County as made applicable to the Town pursuant to the Town Charter) the Town Council has held a public hearing to consider the designation of the roadway.

WHEREFORE, the Town Council directs staff to take all the steps necessary to immediately co-designate the portion of Northwest 89<sup>th</sup> Avenue directly in front of Barbara Goleman Senior High School as Northwest 89<sup>th</sup> Avenue/"Barbara Goleman Way."

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and are incorporated herein by this reference.

Section 2. Designation of Roadway. Northwest 89<sup>th</sup> Avenue directly in front of Barbara Goleman Senior High School is designated as Northwest 89<sup>th</sup> Avenue/"Barbara Goleman Way."

<u>Section 3.</u> <u>Authorization of Town Officials.</u> The Town Manager and/or his designee and the Town Attorney are authorized to take all actions necessary to implement this Resolution.

Section 4. Direction to Clerk. The Town Clerk is directed to send a certified copy of this resolution to the United States Postal Service in order to verify the street designation for postal records.

Section 5. Effective Date. This Resolution shall take effect immediately upon its adoption.
