

RESOLUTION NO. 10-817

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; ACCEPTING THE REQUEST OF MARCELO M. MERLO TO REDUCE A PREVIOUSLY ASSESSED CODE COMPLIANCE FINE FOR CASE NO. C2006-0669; DIRECTING THE TOWN MANAGER TO EXECUTE ANY REQUIRED DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Miami Lakes (the "Town"), through its Code Compliance Department, issued Citation No. C2006-0669 to Harvey Goodman (the "Previous Owner"); and

**WHEREAS**, ownership of the property is proposed to be transferred to Marcelo M. Merlo; and

**WHEREAS**, a Citation was issued and the violation was subsequently corrected; and

**WHEREAS**, the Owner has incurred a fine of \$14,067.58; and

**WHEREAS**, the Owner has authorized the Contract Purchaser to request that the Town reduce the fine and the Interim Town Manager having reviewed the file has recommended to the Town Council approval of a 50% reduction of the fine of \$7,034.29 leaving a balance to be paid in the amount of \$7,034.29.

**WHEREAS**, the Contract Purchaser has agreed to sign a release of the Town from any claims relating to the Citation as a condition of the reduction.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and are incorporated herein by this reference.

**Section 2. Reduction of Fine.** The civil penalty/fine for Code Compliance Case No. C2006-0669 is reduced to \$320.22 subject to the Contract Purchaser paying the reduced amount no later than 60 days from the effective date of this Resolution. The Town Manager is authorized to execute appropriate documents, including a release and waiver by the Contract Purchaser for any and all claims relating to the citation and this reduction.

**Section 3. Conditions.** In the event the reduced fine is not paid within sixty (60) days of the effective date of this Resolution, the original fine amount shall be reinstated and continue to accrue interest as if this Resolution had not existed.

**Section 4. Effective Date.** This Resolution shall be effective immediately upon adoption.




