WHEREAS, the Town Council approves the recommendation and authorizes the Town Manager to negotiate a contract with Sprint Nextel to provide cell phone service for the Town.

<u>Section 3.</u> <u>Authorization of Town Manager.</u> The Town Manger is hereby authorized to negotiate a contract for cell phone service (the "Contract"), together with such changes as may be acceptable to the Town Manager and approved as to form and legality by the Town Attorney, in an amount not to exceed the budgeted amount for such services.

Section 4. Authorization of Town Officials. The Town Manager and Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract.

Section 5. Authorization of Fund Expenditure. Notwithstanding the limitations imposed upon the Town Manager pursuant to the Town's Purchasing Procedures Ordinance, the Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the Contract.

Section 6. Execution of a Contract. The Town Manager is authorized to execute a Contract on behalf of the Town, to execute any required agreements and/or documents to implement the terms and conditions of a Contract and to execute any extensions and/or amendments to the Contract, subject to the approval as to form and legality by the Town Attorney.

Section 7. Effective Date. This Resolution shall take effect immediately upon adoption.
