

**RESOLUTION NO. 10-828**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, DIRECTING STAFF TO IDENTIFY ANY AND ALL MEANS TO ENSURE ENFORCEMENT OF THE TOWN'S SEXUAL OFFENDER ORDINANCE AS AN URGENT MATTER OF PUBLIC SAFETY; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the protection of our children is of paramount importance to the Town Council and the residents of the Town of Miami Lakes (the "Town"); and

**WHEREAS**, on July 12, 2005, the Town Council adopted sexual offender residency prohibitions and restrictions in Ordinance No. 05-71 (the "Sexual Offender Ordinance"); and

**WHEREAS**, Miami-Dade County has adopted legislation which provides less stringent residency standards than those adopted by the Town; and

**WHEREAS**, the Town Council wishes to enforce the Town's Sexual Offender Ordinance and residency restrictions provided therein, for the maximum protection of the Town's children.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1.    Recitals.** The above recitals are true and correct and are incorporated herein by this reference.

**Section 2.    Direction For Enforcement.** The Town Council directs staff to pursue the enforcement of the Town's Sexual Offender Ordinance through the Town's Police and Code Enforcement Departments and to provide a follow-up report on the enforcement efforts and identify any and all additional actions, including legal actions, which may need to be taken to actively pursue enforcement, by the September, 2010 Town Council meeting.


**Section 3. Effective Date.** This Resolution shall become effective immediately upon its adoption.




