WHEREAS, the Town of Miami Lakes (the "Town"), through its Code Compliance Department, issued Citation No. C2009-0621 ("Citation") to 1997 M L E LC c/o CVS Pharmacy Inc. (the "Owners"); and

WHEREAS, a Citation was issued and the violation was subsequently corrected; and

WHEREAS, the Owners have incurred a fine of \$5,578.84; and

WHEREAS, the Owners have requested that the Town reduce the fine and the Interim Town Manager having reviewed the file has recommended to the Town Council approval of a 50% reduction of the fine of \$2,789.42, leaving a balance to be paid in the amount of \$2,789.42; and

WHEREAS, the Owners have agreed to sign a release of the Town from any claims relating to the Citation as a condition of the reduction.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:
