

RESOLUTION NO. 10-~~833~~

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; ACCEPTING THE REQUEST OF HOLLAND & KNIGHT ON BEHALF OF CVS PHARMACY (C/O THE GRAHAM COMPANIES) TO REDUCE A PREVIOUSLY ASSESSED CODE COMPLIANCE FINE FOR CASE NO. C2009-0593; DIRECTING THE TOWN MANAGER TO EXECUTE ANY REQUIRED DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the "Town"), through its Code Compliance Department, issued Citation No. C2009-0593 ("Citation") to The Graham Companies C/O CVS Corporation (the "Owners"); and

WHEREAS, a Citation was issued and the violation was subsequently corrected; and

WHEREAS, the Owners have incurred a fine of \$10,592.89; and

WHEREAS, the Owners have requested that the Town reduce the fine and the Interim Town Manager having reviewed the file has recommended to the Town Council approval of a 50% reduction of the fine of \$5,296.44, leaving a balance to be paid in the amount of \$5,296.45; and

WHEREAS, the Owners have agreed to sign a release of the Town from any claims relating to the Citation as a condition of the reduction.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

**Section 1.** **Recitals.** The above recitals are true and correct and are incorporated herein by this reference.

**Section 2.** **Reduction of Fine.** The civil penalty/fine for Code Compliance Case No. C2009-0593 is reduced to \$5,296.45 subject to the Owners paying the reduced




