RESOLUTION NO. 10-848

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, DESIGNATING NW 77th COURT/PALMETTO FRONTAGE ROAD AS "ORANGE BOWL WAY"; AUTHORIZING TOWN OFFICIALS TO TAKE ALL STEPS NECESSARY TO DESIGNATE THE ROAD; DIRECTING THE CLERK TO NOTIFY THE UNITED STATES POST OFFICE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Orange Bowl Committee has become a community fixture with South Florida; and

WHEREAS, the offices of the Orange Bowl Committee are located on what is now 77th

Court/Palmetto Frontage Road in the Town of Miami Lakes; and

WHEREAS, the Florida Legislature approved, and the Governor signed, House Bill 321, designating NW 77th Court/Palmetto Frontage Road as "Orange Bowl Way"; and

WHEREAS, in further support of the tenure, positive impact, and commitment of the ongoing relationship between the Orange Bowl Committee and the Town of Miami Lakes; and

WHEREAS, pursuant to Section 2-1, Rule 9.02 of the Town Code (Miami-Dade County as made applicable to the Town pursuant to the Town Charter) the Town Council has held a public hearing to consider the designation of the roadway.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1</u>. <u>Recitals</u>. The foregoing Recitals are true and correct and are incorporated herein by this reference.

Section 2. Designation of Roadway. 77th Court/Palmetto Frontage Road is designated as "Orange Bowl Way".

Section 3. Authorization of Town Officials. The Town Manager and/or his designee and the Town Attorney are authorized to take all actions necessary to implement this Resolution.

<u>Section 4.</u> <u>Direction to Clerk.</u> The Town Clerk is directed to send a certified copy of this resolution to the United States Postal Service in order to verify the street designation for postal records.

Section 5. Effective Date. This Resolution shall take effect immediately upon its adoption.
