

RESOLUTION NO. 11-922

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, REITERATING OPPOSITION TO ANY COMMERCIAL AVIATION BEING PERMITTED AT OPA-LOCKA AIRPORT; AUTHORIZING TOWN OFFICIALS TO TRANSMIT THE RESOLUTION; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes is home to over five schools and other educational institutions; and

WHEREAS, the Town of Miami Lakes is home to 30,000 residents and multiple businesses, churches and social centers; and

WHEREAS, because of its proximity to Opa-Locka Airport, the Town of Miami Lakes is affected by the noise of the aircrafts flying over Miami Lakes; and

WHEREAS, the Town of Miami Lakes has a vested interest in monitoring aviation and other activities at Opa-Locka Airport in order to protect the health and welfare of our residents; and

WHEREAS, the Town of Miami Lakes has consistently opposed all efforts to place any type of commercial aviation at Opa-Locka Airport; and

WHEREAS, it is possible to engage in mutually beneficial commercial activity without flying commercial planes into Opa-Locka airport, which should never be considered.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above Recitals are true and correct and incorporated herein by this reference.

Section 2. Opposition to Re-Zoning for Commercial Aviation Use at The Opa-Locka Airport. The Town Council hereby opposes any commercial aviation at the Opa-Locka airport.

Section 3. Transmittal. The Town Clerk is directed to forward a copy of this Resolution to all appropriate County, State and Federal agencies

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.


