

**RESOLUTION NO. 11-928**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, TO AUTHORIZE THE TOWN MANAGER TO ACCEPT THE SAFE NEIGHBORHOOD PARKS GRANT IN THE AMOUNT OF \$346,100.00; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, in 2004, the Town was awarded \$346,100.00 in Safe Neighborhood Parks (SNP) funds, which were to be used for Royal Oaks Park (\$200,000.00), Sevilla Estates Park (\$100,000.00), and Miami Lakes Park (\$46,100.00); and

**WHEREAS**, the release of the funds was delayed, and due to the lapse of time, reimbursement for the Royal Oaks Community Center project is no longer eligible; and

**WHEREAS**, the Town will accept the \$346,100.00 grant and utilize \$146,000.00 on the Mini Tot Lot Playground Renovation (12 Parks), and Resurfacing at Royal Oaks Park; \$100,000.00 on Miami Lakes Optimist Park Boundless Playground; and \$100,000.00 on Sevilla Estates Park; and

**WHEREAS**, the Town's required match is \$346,100.00, which will be allocated from the Capital Project Fund; and

**WHEREAS**, the Town Council, desires the Town Manager to accept the Safe Neighborhood Parks Grant totaling \$346,100.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above Recitals are true and correct and incorporated herein by this reference.

**Section 2. Authorization of Town Manager.** The Town Council hereby authorizes the Town Manager to accept the Safe Neighborhood Parks Grant totaling \$346,100.00, with the Town's matching \$346,100.00, to be allocated from the Capital Project Fund, all funds to be spent as provided herein. The Manager is authorized to execute any and all necessary documents pertinent to receiving these grant funds.


**Section 3. Effective Date.** This Resolution shall take effect immediately upon adoption.


