RESOLUTION NO. 11-929

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, TO AUTHORIZE THE TOWN MANAGER TO SIGN A GRANT OF EASEMENT TO THE MIAMIDADE WATER AND SEWER DEPARTMENT FOR POCKET PARK 10 ON LOCH NESS DRIVE; AUTHORIZING THE TOWN MANAGER AND TOWN ATTORNEY TO IMPLEMENT THE TERMS AND CONDITIONS OF THE GRANT OF EASEMENT; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE GRANT OF EASEMENT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Miami-Dade County has transferred title for the Town's local parks to the Town of Miami Lakes (the "Town"); and

WHEREAS, some of the parks include Miami-Dade Water and Sewer Department transmission and distribution facilities, such as pump stations; and

WHEREAS, since the Town holds title to the properties, a Grant of Easement has been requested to permit MDWASD legal access to and use of portions of the property; and

WHEREAS, the MDWASD has requested a Grant of Easement for pocket park 51 on Loch Ness Drive; and

WHEREAS, the Town Council authorizes the Town Manager authority to execute the Grant of Easement to Miami-Dade Water and Sewer Department (MDWASD) for pocket park 51 on Loch Ness Drive, which houses MDWASD equipment.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated into this resolution by this reference.

Section 2. Approval of Interlocal Agreement. The Town Manager is hereby authorized to execute a Grant of Easement between the Town of Miami Lakes and Miami-Dade Water and Sewer Department providing for legal access to and use of pocket park 51 on LochNess

Drive (the "Grant of Easement"), in such a form as may be acceptable to the Town Manager and approved as to form and legality by the Town Attorney.

Authorization of Town Officials. The Town Manager and Town Attorney Section 3. are authorized to take all steps necessary to implement the terms and conditions of the Grant of Easement.

Execution of the Grant of Easement. The Town Manager is authorized to Section 4. execute the Grant of Easement on behalf of the Town.

Effective Date. This Resolution shall take effect immediately upon adoption. Section 5.




