

RESOLUTION NO. 11- 946

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES FLORIDA TO SUPPORT AND REQUEST THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) TO EXPEDITE FUNDING OF A SOUND BARRIER, TO PROTECT THE QUALITY OF LIFE FOR THE RESIDENTS OF MIAMI LAKES; DIRECTING THE TOWN CLERK TO FORWARD THE RESOLUTION; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the residents of Miami Lakes require relief from the growing noise pollution from automobiles on the highways; and

WHEREAS the Town of Council of the Town of Miami Lakes supports and encourages the Florida Department of Transportation (FDOT) to expedite the construction of a Sound Barrier for the residents of Miami Lakes; and

WHEREAS, the need of a sound barrier is essential for the residents of Loch Ness and Windmill Gate; and

WHEREAS, the sound barrier is needed to alleviate the noise pollution adversely affecting the residents; and

WHEREAS the Town Council of the Town of Miami Lakes supports and requests that Florida Department of Transportation (FDOT) expedite funding for a sound barrier for the residents of Miami Lakes.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:


Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
