

RESOLUTION NO. 12-1006

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, TO APPROVE AWARD OF CONTRACT FOR ITB 2012-19, DEBRIS MANAGEMENT SERVICES TO ASHBRIIT ENVIRONMENTAL AS PRIMARY CONTRACTOR AND CERES ENVIRONMENTAL SERVICES, INC. AS SECONDARY CONTRACTOR; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the "Town") issued an Invitation to Bid ("ITB") No. 2012-19 on May 23, 2012, for Debris Management Services; and

WHEREAS, an Evaluation Committee has determined that Ceres Environmental Services, Inc. ("Ceres") is the lowest responsive and responsible bidder and recommends Award of Contract ITB 2012-19 to same as primary contractor and to Ashbriit Environmental ("Ashbriit") as secondary contractor; and

WHEREAS, Ashbriit and Ceres, will be responsible for furnishing all labor, materials, tools, means of transportation, supplies, equipment and services necessary to complete all the removal and disposal of debris resulting from a disaster event in the Town; and

WHEREAS, the Town Council denies the recommendations of the Evaluation Committee and authorizes the Town Manager to enter into contract with Ashbriit Environmental as primary contractor and Ceres as secondary contractor, for Award of Contract ITB 2012-19, for Debris Management Services, in an amount to be allocated on an as needed basis in response to a disaster event on an as needed basis.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF
THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

Section 1. Recitals. The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves the award of ITB No. 2012-19, to Ashbritt and Ceres, in an amount to be allocated on an as needed basis for Debris Management Services.

Section 3. Authorization of Town Officials. The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract with Ashbritt and Ceres for Debris Management Services.

Section 4. Execution of the Contract. The Town Manager is authorized to execute the Contract with Ashbritt and Ceres for debris management services on behalf of the Town for Debris Management Services, in the amount to be allocated on an as needed basis, in substantially the form attached hereto.


Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
