

RESOLUTION NO. 12-1028

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, TO APPROVE A WORK ORDER PROPOSAL TO BERMELLO AJAMIL AND PARTNERS, INC, FOR A TOWN-WIDE BEAUTIFICATION MASTER PLAN, IN THE AMOUNT OF \$48,426; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Town of Miami Lakes (the “Town”) is committed to renew its urban beautification effort to become the most uniformly beautiful municipality in South Florida; and

WHEREAS, the Town requested a work order proposal from one of the Town’s contracted architectural firms, Bermello Ajamil and Partners, Inc., for a beautification Master Plan; and

WHEREAS, the beautification Master Plan will serve as a vision and guide as to how the physical environment within the Town should be articulated, and will address issues including median planting improvements, pocket/neighborhood park beautification, gateways, and other right-of-way improvements typical of most streetscape beautification projects; and

WHEREAS, the Town Council desires to approve the Work Order Proposal from Bermello Ajamil and Partners, Inc, for a Town-wide beautification Master Plan, in the amount of \$48,426.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves the Work Order Proposal from Bermello Ajamil and Partners, Inc., for Town-wide beautification Master Plan.

Section 3. Authorization of Town Manager. The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Work Order Proposal from Bermello Ajamil and Partners, Inc., for a town-wide beautification Master Plan.

Section 4. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the Work Order.

Section 5. Execution of the Contract. The Town Manager is authorized to execute a Contracts on behalf of the Town, for a beautification Master Plan, with Bermello Ajamil and Partners, Inc., in the amount of \$48,256, payable from the FY2012-13 Public Work Department Fund; subject to the approval as to form and legality by the Town Attorney.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.

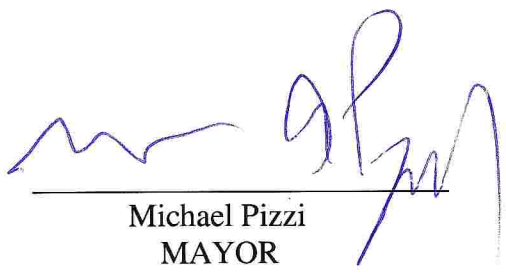

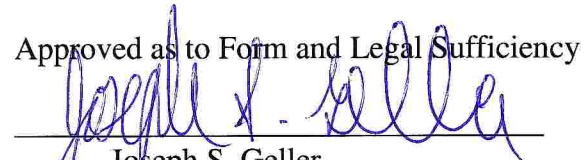
