RESOLUTION NO. 12-1036

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, URGING A CONSENSUS FOR NAMING, RE-NAMING OR CO-DESIGNATING **STREETS** AND STRUCTURES: PROVIDING FOR INCORPORATION OF RECITALS; **PROVIDING** FOR CONFLICT AND REPEALER: PROVIDING FOR VOTING REQUIREMENTS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Miami Lakes desires to continue naming, re-naming and co-designating certain streets and structures located within the Town of Miami Lakes; and

WHEREAS, the naming, re-naming and co-designation of certain streets and structures should not be controversial; and

WHEREAS, the Town Council feels that it is appropriate that the naming, renaming and co-designation of certain streets and structures should be based on a general consensus of the community and the Town Council; and

WHEREAS, the naming of streets and structures in honor of a living individual should require a unanimous vote of the entire Council; and

WHEREAS, the naming of streets and structures in honor of a deceased individual should require a vote of a supermajority, plus one, of the entire Council; and

WHEREAS, this Council action should only be brought forth at a Regular Council Meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Conflict. This resolution supplements and supersedes where there is conflict with any other Town laws, and any such conflicting laws, ordinances, and resolutions are hereby repealed to the extent of the conflict.

Section 3. Voting Requirements. All future street and structure naming in honor of a living individual must be approved by a unanimous vote of the entire Council. All future street and structure naming in honor of a deceased individual must be approved a vote of a supermajority, plus one, of the entire Council. This Council action should only be brought forth for Council discussion and vote at a Regular Council Meeting.

Section 4. Effective Date. This Resolution shall become effective immediately upon its adoption.
