## **RESOLUTION NO. 12-978**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; ACCEPTING THE REQUEST OF MAUREEN DIAZ (VICTORY PETROLEUM) ON BEHALF OF ST. GEORGES BANK & TRUST COMPANY (CAYMAN), LTD. TO REDUCE PREVIOUSLY ASSESSED CODE COMPLIANCE FINE FOR CASE NO. C2011-2310; DIRECTING THE TOWN MANAGER TO EXECUTE ANY REOUIRED DOCUMENTS; PROVIDING FOR INCORPORATION OF RECITAL: PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Town of Miami Lakes (the "Town"), through its Code Compliance Department, issued Citation No. C2011-2310 ("Citation") to St. Georges Bank & Trust Company (Cayman) LTD. ("Owner"); and

WHEREAS, a Citation was issued and the violation was subsequently corrected by St. Georges Bank & Trust Company (Cayman) LTD. ("Owner"); and

WHEREAS, the Owner incurred a fine of \$5,533.92; and

WHEREAS, the Owner has subsequently corrected the violation and has requested that the Town reduce the fine, and the Town Manager, having reviewed the file, has recommended that the Town Council approve a reduction of 25% of the fines, which is equal to \$1,383.48, leaving a remaining balance to be paid of \$4,150.44; and

**WHEREAS**, the Owner has agreed to sign a release of the Town from any claims relating to the Citation as a condition of the reduction.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

**Section 1**. **Recitals.** The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Reduction of Fine. The civil penalty/fine for Code Compliance

Case No. C2011-2310 is reduced to \$2,766.96 subject to the Owner paying the reduced

amount no later than 60 days from the effective date of this Resolution. The Town Manager is authorized to execute appropriate documents, including a release and waiver by the Owner for any and all claims relating to the Citation and this reduction.

Section 3. **Conditions.** In the event the reduced fine is not paid within sixty (60) days of the effective date of this Resolution, the original fine amount shall be reinstated and continue to accrue interest as if this Resolution had not existed.

Section 4. **Effective Date.** This Resolution shall be effective immediately upon adoption.
