## **RESOLUTION NO. 2012 - 983**

A RESOLUTION OF THE TOWN OF MIAMI LAKES, FLORIDA, TO DESIGNATE A PORTION OF STATE ROAD 826/PALMETTO EXPRESSWAY BETWEEN ON-RAMP 87260330 AND ON RAMP 87260333 IN MIAMI LAKES, FLORIDA, MIAMI-DADE COUNTY AS JIM MANDICH MEMORIAL HIGHWAY; AUTHORIZING THE TOWN MANAGER TO TAKE ALL ACTIONS NECESSARY TO IMPLEMENT THE TERMS AND CONDITION OF THIS RESOLUTION; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, HB 7039, the Road Designation Bill, was passed April 6, 2012, and signed into law by the Governor, providing honorary designation of various transportation facilities in specified counties; and

WHEREAS, among the recommended name changes is one in Miami Lakes, whereby a part of the Palmetto Expressway will be designated as Jim Mandich Memorial Highway, between On-Ramp 87260330 and On-Ramp 87260333 of State Road 826/Palmetto Expressway in Miami-Dade County; and

WHEREAS, the Town Council of the Town of Miami Lakes desires to approve designating a portion of State Road 826/Palmetto Expressway as Jim Mandich Memorial Highway; and

WHEREAS, the Town Council desires to notify the Florida Department of Transportation of the Town's decision to designate, said portion of State Road 826/Palmetto Expressway as Jim Mandich Memorial Highway.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The recitals are true and correct and are incorporated herein by this reference.

Section 2. Designation. The Town Council of the Town of Miami Lakes hereby designates a portion of State Road 826/Palmetto Expressway in Miami Lakes, Florida, between On-Ramp 87260330 and On-Ramp 87260333, as Jim Mandich Memorial Highway.

Section 3. Implementation. The Town Manager is hereby authorized to take all necessary action to implement the terms and condition of this resolutions.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
