

RESOLUTION NO. 13-1051

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, TO APPROVE AWARD OF CONTRACT FOR REQUEST FOR PRICE QUOTATION 2013-08, GOVERNMENT CENTER FURNITURE, IN AN AMOUNT NOT TO EXCEED \$55,000.00 TO PRADERE OFFICE PRODUCTS; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the "Town") issued an Request for Price Quotation ("RPQ") No. 2013-08A and 2013-08B ("2013-08") on December 12, 2012, for Government Center Furniture; and

WHEREAS, the Town Manager, has determined that Pradere Office Products ("Pradere"), is the lowest responsive and responsible bidder, and recommends Award of Contract RPQ 2013-08 to same; and

WHEREAS, Pradere, will be responsible to provide the Town with office furniture required for the new Government Center under an existing State of Florida contract; and

WHEREAS, the Town Council approves the recommendations of the Town Manager and authorizes the Town Manager to enter into a contract with Pradere, for Award of Contract 2013-08, for Government Center Furniture, in an amount not to exceed \$55,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves the award of RPQ No. 2013-08, to Pradere Office Products in an amount not to exceed \$55,000.00 for Government Center Furniture.

Section 3. Authorization of Town Officials. The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract with Pradere for Government Center Furniture, and/or other ancillary furniture for Town facilities currently under construction.

Section 4. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the Contract from the FY 2013 General and Capital Projects Fund Budgets.

Section 5. Execution of the Contract. The Town Manager is authorized to execute the Contract with Pradere for Government Center Furniture on behalf of the Town, in the amount not to exceed \$55,000.00, in substantially the form attached hereto.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.


