A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, TO APPROVE AWARD OF CONTRACT 2013-22 ACCESSING CONTRACT #066-2730-12/DJL FOR SOD AND SOD INSTALLATION, AS LONG AS BUDGETED FUNDS ARE AVAILABLE FOR THESE GOODS AND SERVICES; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS THE AND CONDITIONS OF CONTRACT: AUTHORIZING MANAGER THE TOWN TO **BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER CONTRACT:** EXECUTE THE **PROVIDING** INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the "Town") wishes to access the Southeast Florida Governmental Purchasing Cooperative Group Contract #066-2730-12/DJL for sod and sod installation; and

WHEREAS, the Southeast Florida Governmental Purchasing Cooperative Group, comprised of forty-five agencies, was created to utilize the buying power of combined requirements for common basic commodities/services to promote cost savings and cost avoidances to each entity; and

WHEREAS, on August 29, 2012, the City of Boyton Beach received five (5) proposals for sod and sod installation; and

WHEREAS, as a result, several bidders (Mullings Engineering Services, LLC., Odum's Sods, Inc., South Florida Grassing, Inc., Sunset Sod, Inc., and Tropical Landscaping and Lawn Maintenance, Inc.) were awarded contracts as the most responsive, responsible bidders; and

WHEREAS, the Town Council approves the recommendation of the Town Manager and authorizes the Town Manager to enter into Contract 2013-22, accessing contract #066-2730-

12/DJL, for Sod and Sod Installation, as long as budgeted funds are available for these goods and services.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves the award of Contract 2013-22, accessing contract #066-2730-12/DJL, for Sod and Sod Installation, as long as budgeted funds are available for these goods and services.

Section 3. Authorization of Town Officials. The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract for Sod and Sod Installation.

Section 4. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the Contract as long as budgeted funds are available for these goods and services.

Section 5. Execution of the Contract. The Town Manager is authorized to execute the Contract 2013-22 for Sod and Sod Installation on behalf of the Town, as long as budgeted funds are available for such goods and services, in substantially the form attached hereto.
