A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, TO AUTHORIZE THE TOWN MANAGER TO AWARD A CONTRACT TO SUPERIOR LANDSCAPING & LAWN SERVICE, INC., FOR **FDOT** GROUND **MAINTENANCE SERVICES**; AUTHORIZING THE TOWN MANAGER AND TOWN **IMPLEMENT** THE TERMS ATTORNEY TO CONDITIONS OF THE AGREEMENT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE AGREEMENT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Town of Miami Lakes (the "Town") issued an Invitation to Bid ("ITB") on December 6, 2012, for FDOT Ground Maintenances Services; and

WHEREAS, the landscaping servicer will provide services such as mowing, edging, trimming, maintenance of shrubs, hedges, plants, fertilizing, mulching, and debris pick-up on FDOT sites as identified in the contract document; and

WHEREAS, the responsive proposers are required to hold a current Landscape License/Certification issued by Miami-Dade County and must meet the Federal Homeland Security E-Verify requirements, possess a minimum of five (5) years experience in ground maintenance service in its current business name/ownership; and

WHEREAS, the Town Manager, has determined that Superior Landscaping & Lawn Service, Inc. ("Superior"), is the lowest responsive and responsible bidder, and

WHEREAS, the Town Council approves the recommendations of the Town Manager and authorizes the Town Manager to enter into a contract with Superior Landscaping & Lawn Service, Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves the award of the contract to Superior Landscaping & Lawn Service, Inc., for FDOT Ground Maintenance Services. If the Town is not able to finalize an agreement with Superior, then it shall negotiate with the next highest ranked proposer until an agreement is reached.

<u>Section 3.</u> <u>Authorization of Town Manager.</u> The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the contract.

Section 4. Execution of the Contract. The Town Manager is authorized to execute a contract with Superior Landscaping & Lawn Service, Inc, (or, if unsuccessful, with the next highest ranked proposer) to provide ground maintenance service, in an amount not to exceed their bid amount, subject to the approval as to form and legality by the Town Attorney.

<u>Section 5.</u> <u>Authorization of Fund Expenditure</u>. The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the Contracts.
