## **RESOLUTION NO. 13-1062**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES. FLORIDA, **OPPOSING** THE FEDERAL AVIATION **ADMINISTRATION'S DECISION TO CLOSE** THE OPA-LOCKA FLIGHT TOWER: **PROVIDING** FOR **INCORPORATION** RECITALS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Federal Aviation Administration (the "FAA") is considering closing the Airport Tower because of the sequester; and

WHEREAS, the Town of Miami Lakes believes that closing the Opa-Locka Airport Tower will jeopardize the health, safety, and welfare of the residents of Miami Lakes and surrounding areas; and

WHEREAS, the flight tower is necessary to reduce noise pollution over Miami Lakes and surrounding areas; and

WHEREAS, closing the flight tower will allow uncontrolled aviation over densely populated areas, including schools, churches, and thousands of residents; and

WHEREAS, the closing of the flight tower could delay security and safety services provided by police, fire, hospitals, and the U.S. Coast Guard; and

WHEREAS, closing the flight tower would be an irresponsible decision that would jeopardize the safety and quality of life of Miami Lakes and other residents;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above Recitals are true and correct and incorporated herein by this reference.

Section 2. Opposition The Town Council of the Town of Miami Lakes hereby strongly opposes the closure of Opa-locka Airport Tower

Section 3. Transmittal. The Town Clerk is directed to forward a copy of this Resolution to all State Legislators representing the Town of Miami Lakes and to all members of Florida Congressional Delegation.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
