A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, TO APPROVE EXTENSION OF CONTRACT **FOR** MIAMI LAKES **OPTIMIST PARK** MAINTENANCE AGREEMENT, IN AN AMOUNT NOT TO EXCEED \$60,000, WITH VALLEYCREST LANDSCAPE MAINTENANCE, INC.; AUTHORIZING THE TOWN MANAGER TO TAKE ALL STEPS TO IMPLEMENT NECESSARY THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT: PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Town of Miami Lakes (the "Town") contracted with ValleyCrest Landscape Maintenance, Inc. ("ValleyCrest") on April 14, 2003, for Miami Lakes Optimist Park Maintenance; and

WHEREAS, the current agreement with ValleyCrest for Maintenance of Miami Lakes

Optimist Park expires on June 16, 2013;

WHEREAS, the Town Manager, has determined that it is in the best interest of the Town to extend ValleyCrest's contract until early August 2013; and

WHEREAS, the Town Council approves the recommendation of the Town Manager and authorizes the Town Manager to enter into an extension of contract with ValleyCrest for Miami Lakes Optimist Park Maintenance, in an amount not to exceed \$60,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1. Recitals.</u> The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves the extension of contract for Miami Lakes Optimist Park Maintenance with ValleyCrest in an amount not to exceed of \$60,000.00.

Section 3. Authorization of Town Officials. The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the extension of the Contract with ValleyCrest for Miami Lakes Optimist Park Maintenance.

Section 4. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the extension of the Contract from the FY 2013 Budget.

Section 5. Execution of the Extension of the Contract. The Town Manager is authorized to extend the Contract with ValleyCrest for Miami Lakes Optimist Park Maintenance on behalf of the Town, in the amount not to exceed \$60,000.00, in substantially the form attached hereto.
