

**RESOLUTION NO. 13-1081**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, TO APPROVE AWARD OF CONTRACT FOR ITB 2013-19, REFUSE AND RECYCLING SERVICES, IN AN AMOUNT NOT TO EXCEED \$165,855.48 TO ECOLOGICAL PAPER RECYCLING INC.; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Miami Lakes (the "Town") issued an Invitation to Bid ("ITB") No. 2013-19 on March 22, 2013, for Refuse and Recycling Services; and

**WHEREAS**, the Town Manager, has determined that Ecological Paper Recycling, Inc. ("Ecological"), is the lowest responsive and responsible bidder, and recommends Award of Contract ITB 2013-19 to same; and

**WHEREAS**, Ecological, will be responsible for furnishing all labor, materials, machinery, tools, means of transportation, supplies, equipment, and services necessary for refuse and recycling services for Town facilities and parks; and

**WHEREAS**, the Town Council approves the recommendations of the Town Manager and authorizes the Town Manager to enter into contract with Ecological Paper Recycling for Award of Contract ITB 2013-19, for a three (3) year period, for refuse & recycling services, in an amount not to exceed \$165,941.04.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

**Section 2. Approval of the Contract.** The Town Council hereby approves the award of ITB No. 2013-19 to Ecological in an amount not to exceed \$165,941.04, for refuse & recycling services.

**Section 3. Authorization of Town Officials.** The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract with Ecological for refuse & recycling services.

**Section 4. Authorization of Fund Expenditure.** The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the Contract for refuse & recycling services from the Utility and Maintenance line items for the Government Center, Miami Lakes Optimist Park, Parks East & West, and Royal Oaks Park within the General Fund Budget.

**Section 5. Execution of the Contract.** The Town Manager is authorized to execute the Contract with Ecological for refuse & recycling services on behalf of the Town in an amount not to exceed \$165,941.04, in substantially the form attached hereto.


**Section 6. Effective Date.** This Resolution shall take effect immediately upon adoption.


