

**RESOLUTION NO. 13-1098**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, REQUESTING THAT THE STATE CO-DESIGNATE 77<sup>th</sup> AVENUE AS “WELLNESS WAY”; AUTHORIZING TOWN OFFICIALS TO TAKE ALL STEPS NECESSARY TO DESIGNATE THE ROAD; DIRECTING THE CLERK TO NOTIFY THE UNITED STATES POST OFFICE; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, 77th Avenue is located in the Town of Miami Lakes (“Town”); and

**WHEREAS**, the Town is requesting that the State co-designate 77th Avenue as “Wellness Way”; and

**WHEREAS**, the Town Code (Miami-Dade County as made applicable to the Town pursuant to the Town Charter) the Town Council has held a public hearing to consider the co-designation of 77th Avenue as “Wellness Way”.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing Recitals are true and correct and are incorporated herein by this reference.

**Section 2. Co-Designation.** 77<sup>th</sup> Avenue is co-designated as “Wellness Way”, and the Town Council request the State of Florida to co-designate 77th Avenue as “Well Way”.

**Section 3. Authorization of Town Officials.** The Town Manager and/or his designee and the Town Attorney are authorized to take all actions necessary to implement this Resolution.


**Section 4. Direction to Clerk.** The Town Clerk is directed to send a certified copy of this resolution to the United States Postal Service in order to verify the street co-designation for postal records.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption


