

**RESOLUTION NO. 13-1115A**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, REJECTING ALL BIDS FOR NW 154TH STREET ROADWAY AND DRAINAGE CONTRACT, ITB 2013-39; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO REJECT ALL BIDS; AUTHORIZING THE TOWN MANAGER TO REJECT ALL BIDS; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Town of Miami Lakes (the "Town") issued an Invitation to Bid ("ITB") No. 2013-39 on May 29, 2013, for NW 154th Street Roadway & Drainage Improvements; and

**WHEREAS**, the Town Council, has determined that all bids should be rejected; and

**WHEREAS**, the Town Council finds it in the best interest of the Town to reject all bids; and

**WHEREAS**, the Town Council rejects all bids received by the Town of Miami Lakes for ITB 2013-39, and directs the Town Manager to act accordingly.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1.** **Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

**Section 2.** **Authorization to Reject all Bids.** The Town Council hereby rejects all bids received for ITB No. 2013-39 for NW 154th Street Roadway & Drainage Improvements.

**Section 3. Authorization of Town Officials.** The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to reject all bids for NW 154th Street Roadway & Drainage Improvements, pursuant to ITB No. 2013-39.

**Section 4. Effective Date.** This Resolution shall be effective immediately upon adoption.
