A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, TO RATIFY THE CONTRACTS FOR GROUND AND ATHLETIC FIELD MAINTENANCE FOR MIAMI LAKES OPTIMIST PARK AND ROYAL OAKS PARK, RFP 2013-040, AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACTS; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

Section 2. Approval of the Contracts. The Town Council hereby ratifies the execution of the contracts with ValleyCrest and GreenSource for Ground and Athletic Field Maintenance for Miami Lakes Optimist Park and Royal Oaks Park.

Section 3. Authorization of Town Officials. The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contracts with ValleyCrest and GreenSource for Ground and Athletic Field Maintenance for Miami Lakes Optimist Park and Royal Oaks Park.

Section 4. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the Contracts.

Section 5. Execution of the Contracts. The Town Manager is authorized to execute the Contracts with ValleyCrest and GreenSource for Ground and Athletic Field Maintenance for Miami Lakes OptimistPark and Royal Oaks Park.
